## Youth Bowhunting Program Application

### Rules:

1. All qualifying animals must be harvested with archery equipment which is defined as only hand-held, hand-drawn traditional or compound bows that have no mechanical device attached to enable the hunter to hold the bow at full or partial draw. No device may be used to propel the arrow other than the energy stored by the drawn bow.
2. The hunter must harvest a total of five (5) or more of the ten (10) small game animals listed below:
  - a. Bobcat
  - b. Bowfishing (legal fish in respective state)
  - c. Coyote
  - d. Fox
  - e. Javelina
  - f. Rabbit
  - g. Raccoon
  - h. Squirrel
  - i. Turkey
  - j. Opossum
3. All qualifying animals must be harvested under the rules of fair chase as defined by Pope & Young. For this award the club deems animals taken under the following conditions to be ineligible for this award:
  - a. Helpless in a trap, deep snow, or water, or on ice.
  - b. From any power vehicle or power boat.
  - c. While inside escape-proof fenced enclosures.
  - d. By "Jacklighting" or shining at night.
  - e. By the use of any tranquilizers or poisons.
  - f. By the use of any power vehicles or power boat for herding or driving animals, including use of aircraft to land alongside or to communicate with or direct a hunter on the ground.
  - g. By the use of electronic devices for attracting, locating, or pursuing game, or guiding the hunter to such game, or using a bow or arrow to which any electronic device is attached except for lighted nocks and recording devices that cast no light towards the target and do not aid in range finding, sighting, or shooting the bow.
  - h. Any other condition considered by the Pope & Young Board of Directors as unacceptable.
4. To be eligible to receive the award, the hunter must complete the included form and include a photograph of each qualifying animal taken with the applicant and the animal visible in the photograph.
5. All qualifying animals must be harvested with a valid license in accordance with the rules promulgated by the state in which the animal is harvested.
6. All qualifying animals must be harvested prior to the hunter's 18th birthday.
7. Entry into the program provides express consent to Pope & Young, and their corporate partners, to use the photographs of the hunter and their harvest at the club's discretion including on the club's website or any official club social media page.
